1 Disclaimer

This file is a per-person extract of the master dossier (`case_file/case.pdf`). It is not legal advice and must be reviewed by a UAE-licensed lawyer before any complaint is filed. All profane and offensive language is reproduced verbatim in translation, because the exact wording is material to the seriousness of the offences being alleged under UAE law.

2 Identification of this person

Name as stated in the evidence: Syed Faraz Haider.

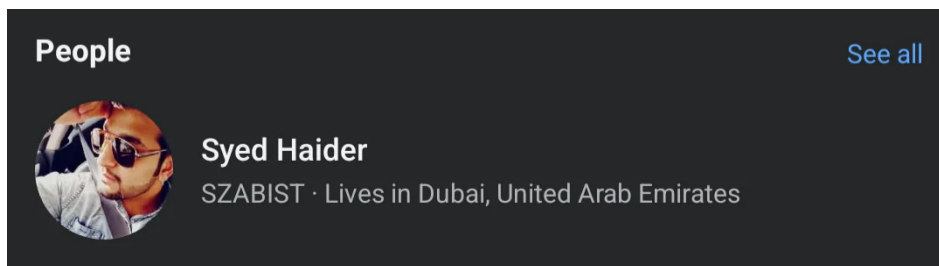
Role: Primary perpetrator. The Complainant met him on an online matrimonial application; he represented himself to her as available for marriage and communicated with her for approximately six months before she discovered that he was already married. The harassment campaign documented in this dossier began after she confronted him.

Public identifiers visible in the evidence:

- **Instagram:** `@faraxhaider` (per the Complainant’s own overview narrative; the handle is not directly screenshotted in the evidence supplied – his photograph from Instagram appears at **EX-02**, **EX-09** and **EX-13**).
- **Facebook (search):** the display name “**Syed Haider**” with tagline “SZABIST – Lives in Dubai, United Arab Emirates” and a profile photograph that matches **EX-02/EX-09/EX-13** (**EX-08**).
- **WhatsApp:** +971 56 330 6663 (UAE number). This is the number from which the abusive WhatsApp messages at **EX-01**, **EX-10**, **EX-15**, **EX-23** and **EX-25** were sent. The Complainant addresses the recipient of **EX-01** by name (“*May u die the most painful death faraz !!!!*”), confirming attribution.

Profession and public presence

The publicly-visible evidence supplied does not state Mr. Haider’s occupation. His Facebook search-result tagline (“**SZABIST · Lives in Dubai, United Arab Emirates**”) identifies him as connected to SZABIST (Shaheed Zulfikar Ali Bhutto Institute of Science & Technology, a private Pakistani university with campuses in Karachi, Islamabad, Larkana and Dubai). His Instagram account `@faraxhaider` is referenced in the Complainant’s overview narrative but is not directly screenshotted in the supplied evidence. His employer / role in Dubai should be confirmed by the investigating officer at the time of verifying his Emirates ID / residence permit.

3 Acts evidenced against the Complainant

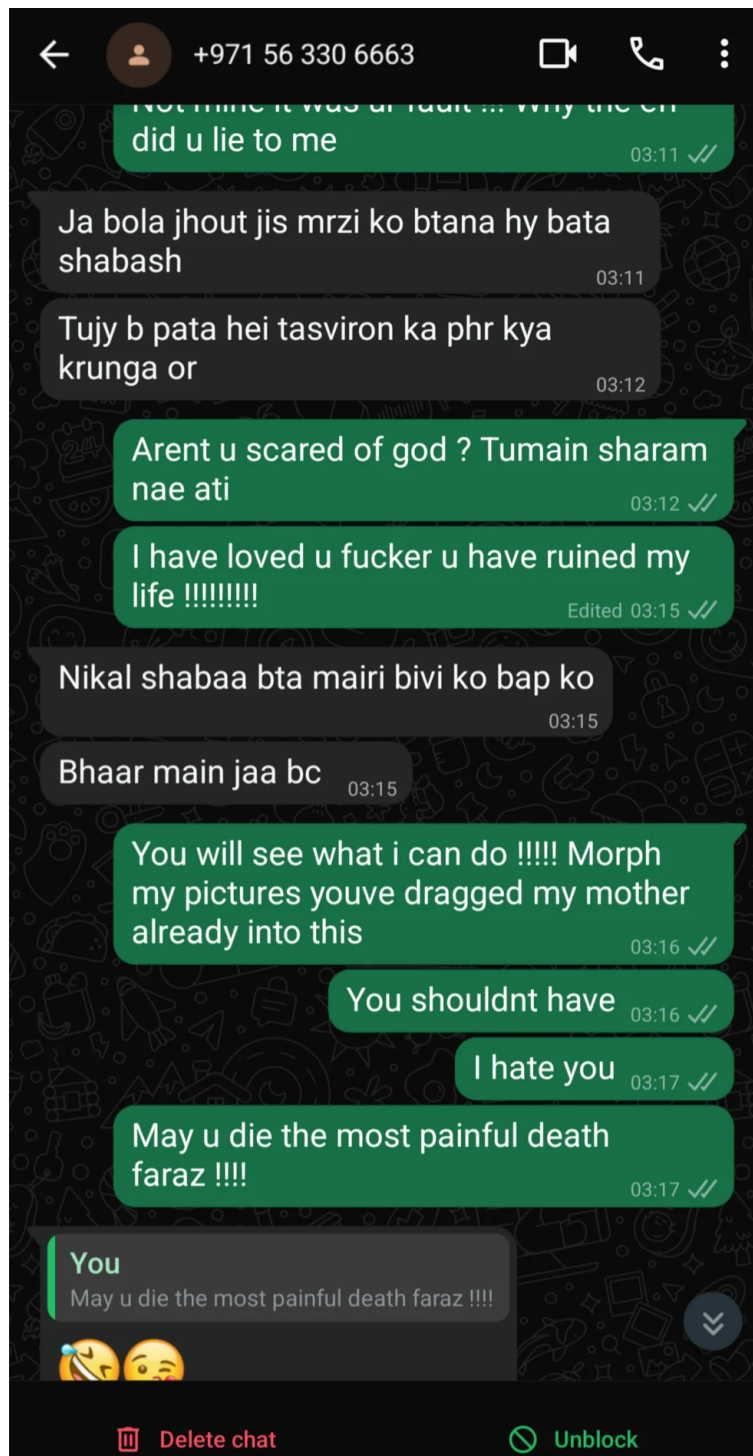
This section reproduces each communication sent by this person, in chronological order across the seven Reddit source posts.

EX-01 — WhatsApp (+971 56 330 6663), source post reddit-1

Brief. Sustained verbal abuse; a coded threat referencing the Complainant’s photographs in his possession; the Complainant accuses him of having dragged her cancer-patient mother into the matter.

English version (his messages in bold; the Complainant’s outgoing in plain text):

- (Complainant) “...not mine, it was your fault...why the hell did you lie to me?” (03:11)
- (Faraz) “**Did I say I’d lie? Tell whoever you want, well done.**” (03:11)
- (Faraz) “**You know about the pictures too – what else am I going to do, then?**” (03:12) — read in context as a threat referencing the Complainant’s photographs in his possession.
- (Complainant) “Aren’t you afraid of God? Don’t you feel ashamed?” (03:12)
- (Complainant) “I loved you, fucker – you have ruined my life!!!!!!!!!!” (edited 03:15)
- (Faraz) “**Then get the hell out – go tell my wife, my father.**” (03:15)
- (Faraz) “**Go to hell, sisterfucker.**” (03:15) — Roman-Urdu “*Bhaar main jaa bc*”; bc = *bhenchod*.
- (Complainant) “You will see what I can do !!!! You morphed my pictures, you’ve dragged my mother already into this.” (03:16)
- (Complainant) “You shouldn’t have.” (03:16)
- (Complainant) “I hate you.” (03:17)
- (Complainant) “May you die the most painful death, Faraz !!!!” (03:17)

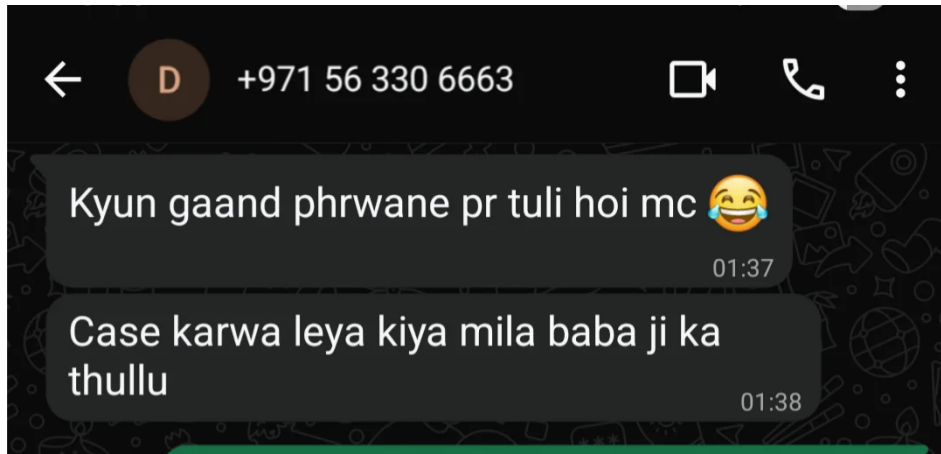

EX-10 / EX-15 — WhatsApp (+971 56 330 6663), source posts reddit-2 & reddit-3

Brief. Obscenities; mockery of the Complainant for filing a case. (**EX-15** is the same screenshot re-posted by the Complainant in a later thread.)

English version:

- “**Why are you hell-bent on getting yourself fucked, sisterfucker?**” (01:37) — Roman-Urdu “*Kyun gaand phrwane pr tuli hoi mc*”; mc = *madarchod*, “motherfucker”.
- “**You filed a case, what did you get – jack shit.**” (01:38) — Roman-Urdu “*Case karwa leya kiya mila baba ji ka thullu*”.

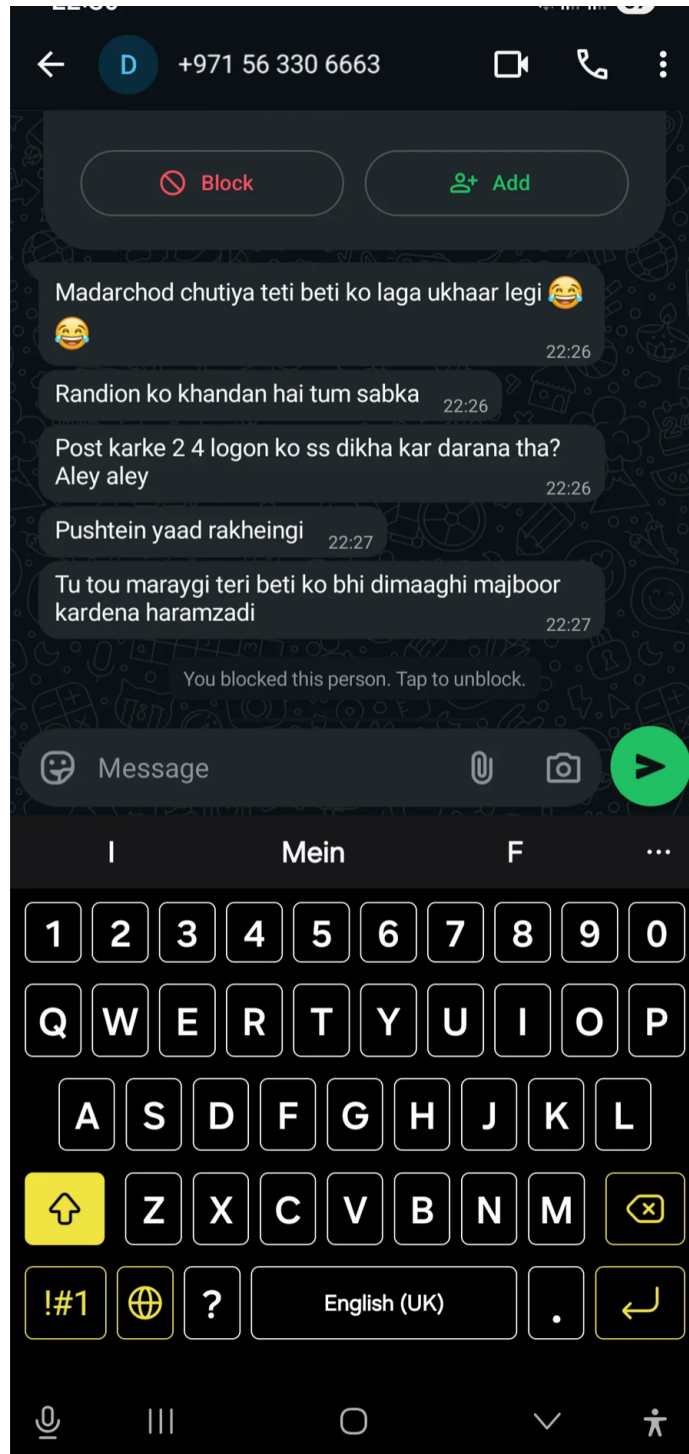

EX-23 — WhatsApp (+971 56 330 6663), source post reddit-4

Brief. Sustained obscenities directed at the Complainant and at female members of her family; a threat that she will drive her own daughter “mentally insane.” The Complainant has *blocked* the sender by this stage of the timeline (the “You blocked this person. Tap to unblock” line is visible at the bottom of the screenshot).

English version:

- **“Motherfucker, do you think your daughter will get you out (of this)?”** (22:22) — *“Madarchod chutiya teti beti ko laga ukhaar legi”*.
- **“You are whore-children – your whole household is.”** (22:22) — *“Randion ko khandan hai tum sabka”*.
- **“Posting screenshots, showing them to two-four people, you thought you’d scare us? Right.”** (22:26) — *“Post karke 2 4 logon ko ss dikha kar darana tha? Akay aley”*.
- **“Generations will remember.”** (22:26) — *“Pushtein yaad rakheingi”*.
- **“You’ll die yourself, you’ll drive your daughter mentally insane too, bastard woman.”** (22:27) — *“Tu tou maraygi teri beti ko bhi dimaaghi majboor kardena haramzadi”*.

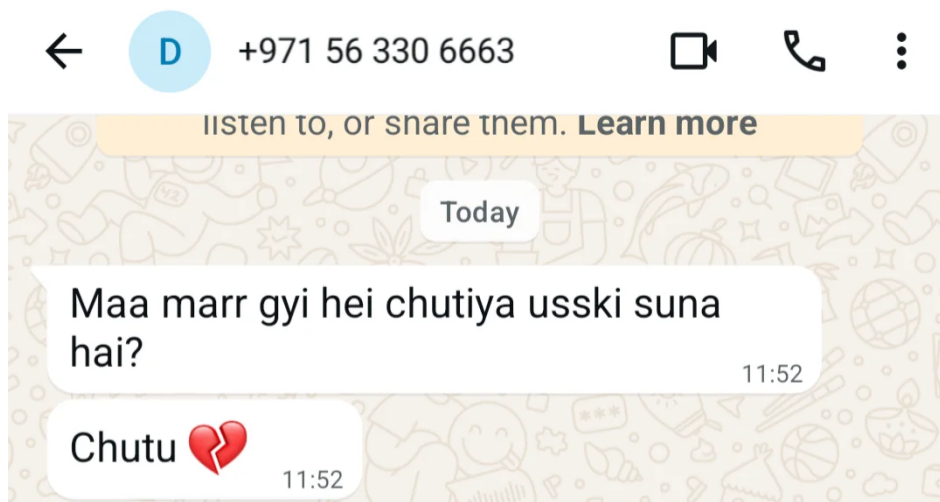

EX-25 — WhatsApp (+971 56 330 6663), source post reddit-5 – AFTER the mother’s death

Brief. Sent *after* the Complainant’s cancer-patient mother had died. The fact that this message was sent at all — after the same number had earlier been told that the Complainant’s mother was a cancer patient and was being dragged into the abuse (**EX-01**) — is direct evidence of knowledge plus continued targeting.

English version:

- “**Heard the bitch’s mother has died?**” (11:52) — “*Maa marr gyi hei chutiya usski suna hai?*”.
- “**Sucker (broken-heart emoji).**” (11:52) — “*Chutu*”.
