Background note: Per the Complainant’s overview, he is alleged to have been “exposed in the past for harassing minors” and to have changed usernames; that allegation is not directly evidenced by exhibits in this dossier and is recorded for context only.

1 Disclaimer

This file is a per-person extract of the master dossier (`case_file/case.pdf`). It is not legal advice and must be reviewed by a UAE-licensed lawyer before any complaint is filed. All profane and offensive language is reproduced verbatim in translation because the exact wording is material to the seriousness of the offences being alleged under UAE law. The Complainant’s overview also notes prior allegations against this person of harassing minors, with username changes; that allegation is recorded here as background only, and is not directly evidenced by the exhibits in this dossier.

2 Identification of this person

Name as stated in the evidence: Syed Bukhari (display name), also identified by the Complainant as “Syed Sheraz Bukhari”.

Role: Brother of the primary perpetrator (Syed Faraz Haider). On being approached by the Complainant to intervene with his brother, he instead joined the harassment, and is the source of the explicit “acid attack” threat at **EX-24**.

Public identifiers visible in the evidence:

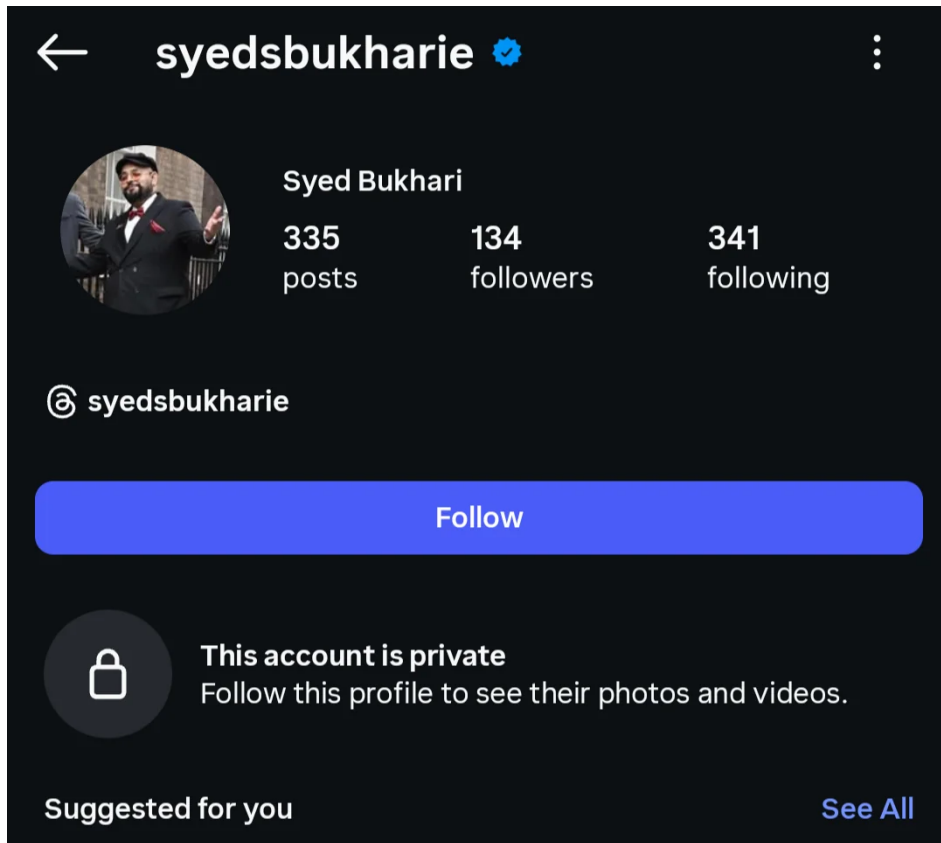
- **X (Twitter):** `@SyedSBukhari` (verified blue tick), display “Syed Bukhari”, Arabic display alongside; “Intellectual”; *joined February 2012*; bio contains two Arabic hashtags transliterated as “Praise God for the blessing of the Emirates / of the people of the Emirates”; 877 Following, 8,146 Followers; organisation banner: “Pakerati”. Pinned post (02 March) extols the UAE: “*A land that has opened its arms to 201 nationalities...*” (**EX-07**). Account was subsequently locked — “These posts are protected” (**EX-21**).
- **Instagram (a):** `@syedsbukharie` (verified blue tick), display “Syed Bukhari”, 335 posts, 134 followers, 341 following, Threads link `syedsbukharie`, account private (**EX-05**).
- **Instagram (b):** `@thesyedbukhari` (verified), display “Syed Bukhari” with Arabic display name; 134–135 followers, 330–331 posts; account private. Used to send **EX-22** and **EX-24**.

Profession and public presence

Mr. Bukhari operates a **verified X (Twitter) account** (`@SyedSBukhari`) with **8,146–8,156 followers**, joined in February 2012, under the organisational banner “**Pakerati**” – a name that visually concatenates “Pakistani” and “Emirati” and is consistent with a Pakistani-Emirati expatriate-community media or commentary presence. His X bio carries two Arabic hashtags transliterating to “*Praise God for the blessing of the Emirates / for the blessing of the people of the Emirates*”, and his pinned post (02 March) is an English-language paean to the UAE as a destination for expatriates (“*a land that has opened its arms to 201 nationalities...*”, with the UAE national emblem). He self-describes on X as an “**Intellectual**”. He additionally operates two **verified Instagram accounts** (`@syedsbukharie` and `@thesyedbukhari`, both private). The combination of a verified X presence over 13 years, two verified Instagram accounts, and an organisational banner suggests an established public-facing online presence within the Pakistani-Emirati community; this is material to Article 52 of Federal Decree-Law 34/2021 (use of a social-media account to spread material prejudicial to a person).

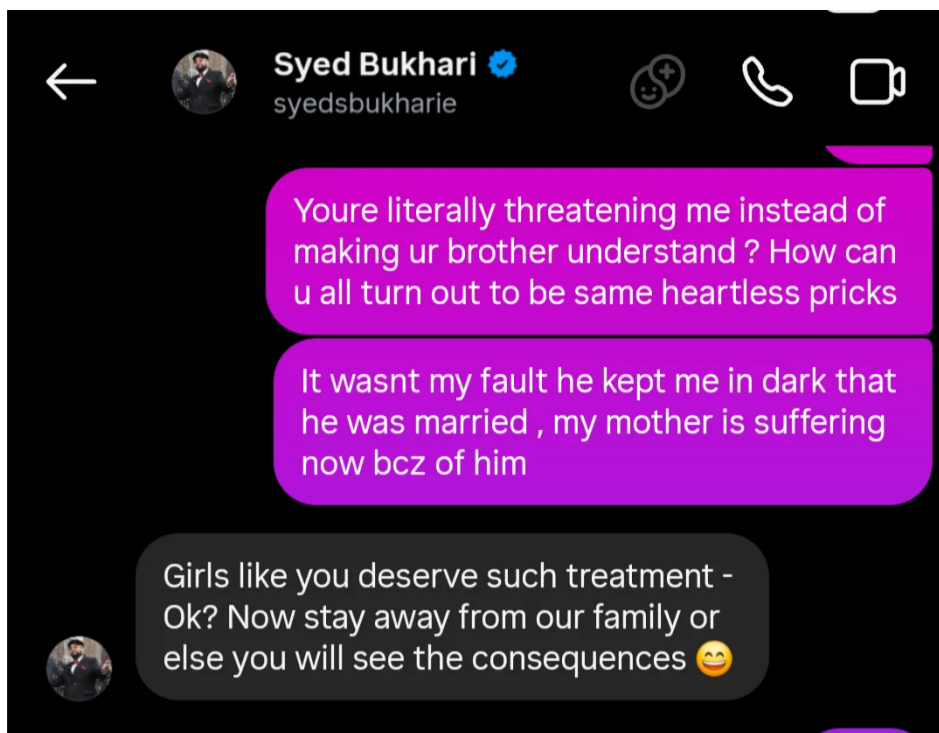
3 Acts evidenced against the Complainant

EX-06 — Instagram DM from @syedsbukharie , source post reddit-1

Brief. The first reply from the brother when the Complainant asks him to intervene with the primary perpetrator. Instead of de-escalating, he tells her “girls like you deserve such treatment.”

English version:

- (Complainant) “You’re literally threatening me instead of making your brother understand? How can you all turn out to be the same heartless pricks?”
- (Complainant) “It wasn’t my fault he kept me in the dark that he was married; my mother is suffering now because of him.”
- (brother) “Girls like you deserve such treatment – Ok? Now stay away from our family or else you will see the consequences :)”

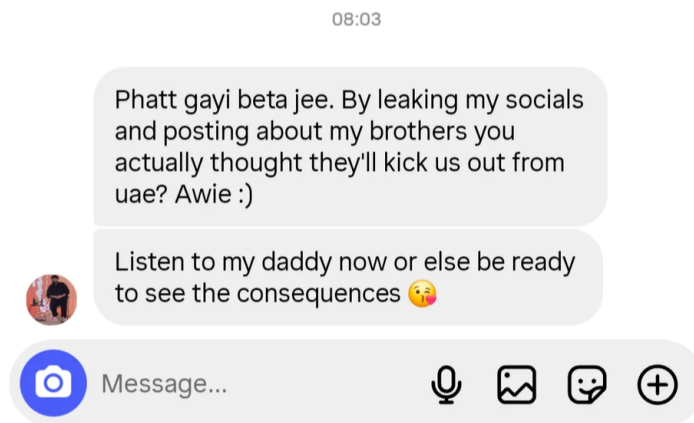
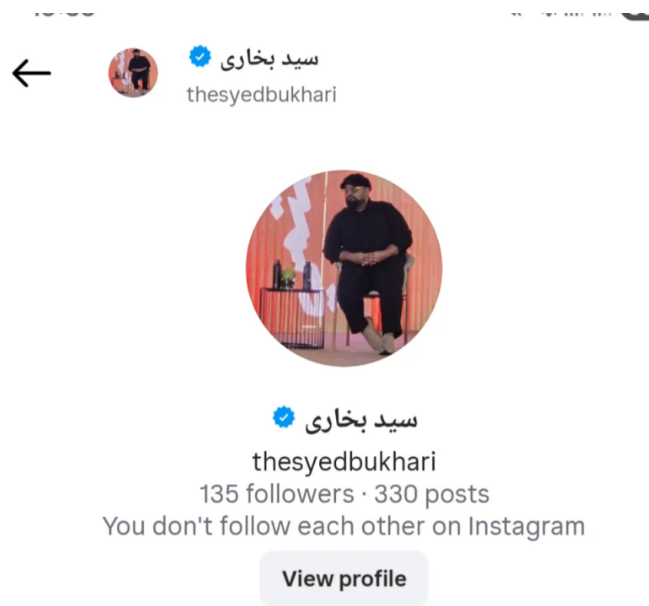

Brief. Taunts the Complainant for trying to “leak” his socials and expose the brothers; mocks the idea that the UAE might take action against the family; instructs her to “listen to my daddy” or face “consequences.”

English version (the exchange is in English):

- “Phatt gayi beta jee.” — approx. “Got scared, kiddo?” (Roman-Urdu *phatt gayi*, crude.)
- “By leaking my socials and posting about my brothers you actually thought they’ll kick us out from uae? Awie :)”
- “Listen to my daddy now or else be ready to see the consequences (winking-face-with-tongue emoji).”

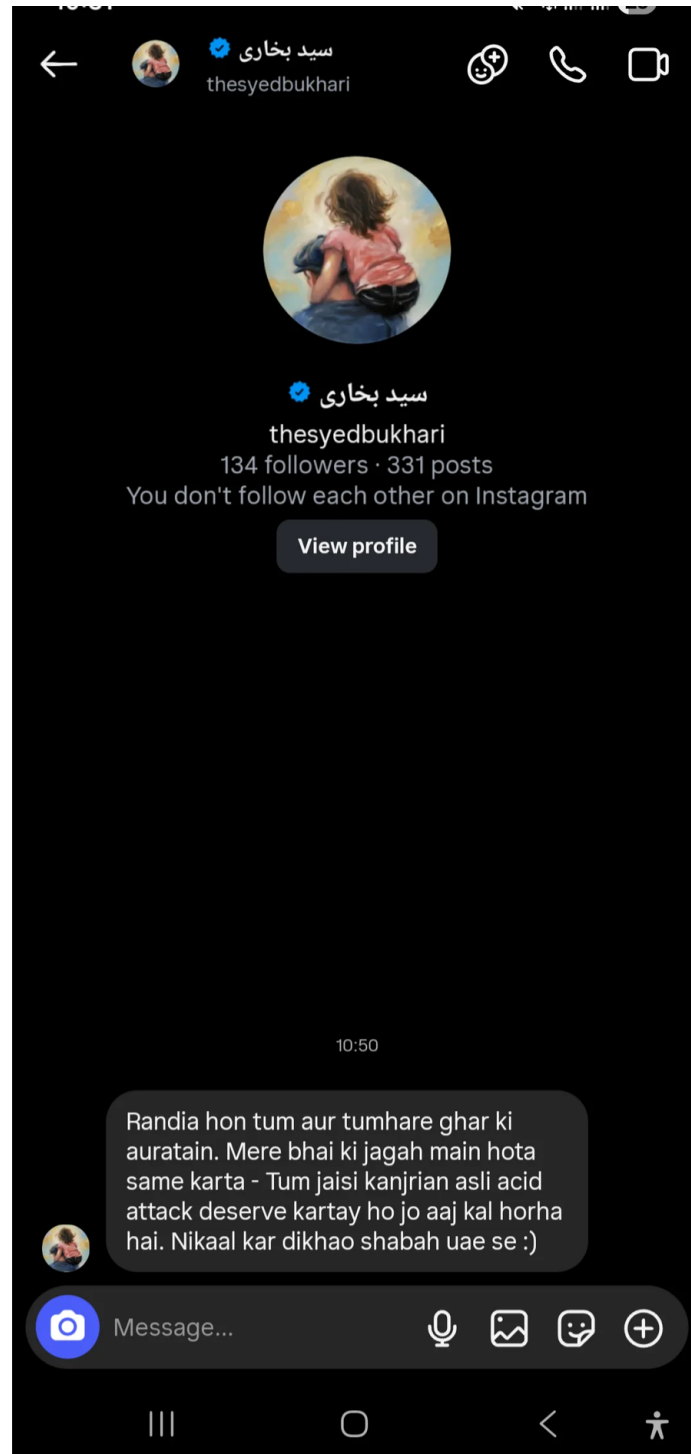

EX-24 — Instagram DM from @thesyedbukhari , source post reddit-4

Brief. The brother calls the Complainant and the women of her family “whores,” and explicitly says they “deserve a real acid attack like the ones happening these days.”

English version:

- **“You are whores, you and the women of your household. If I were in my brother’s place I’d do the same – whores like you deserve a real acid attack like the ones happening these days. Try and get me out of the UAE then (winking-face-with-tongue emoji).”** — Roman-Urdu *“Randia hon tum aur tumhare ghar ki auratain. Mere bhai ki jagah main hota same karta – Tum jaisi kanjrian asli acid attack deserve kartay ho jo aaj kal horha hai. Nikaal kar dikhao shabah uae se :)”*.



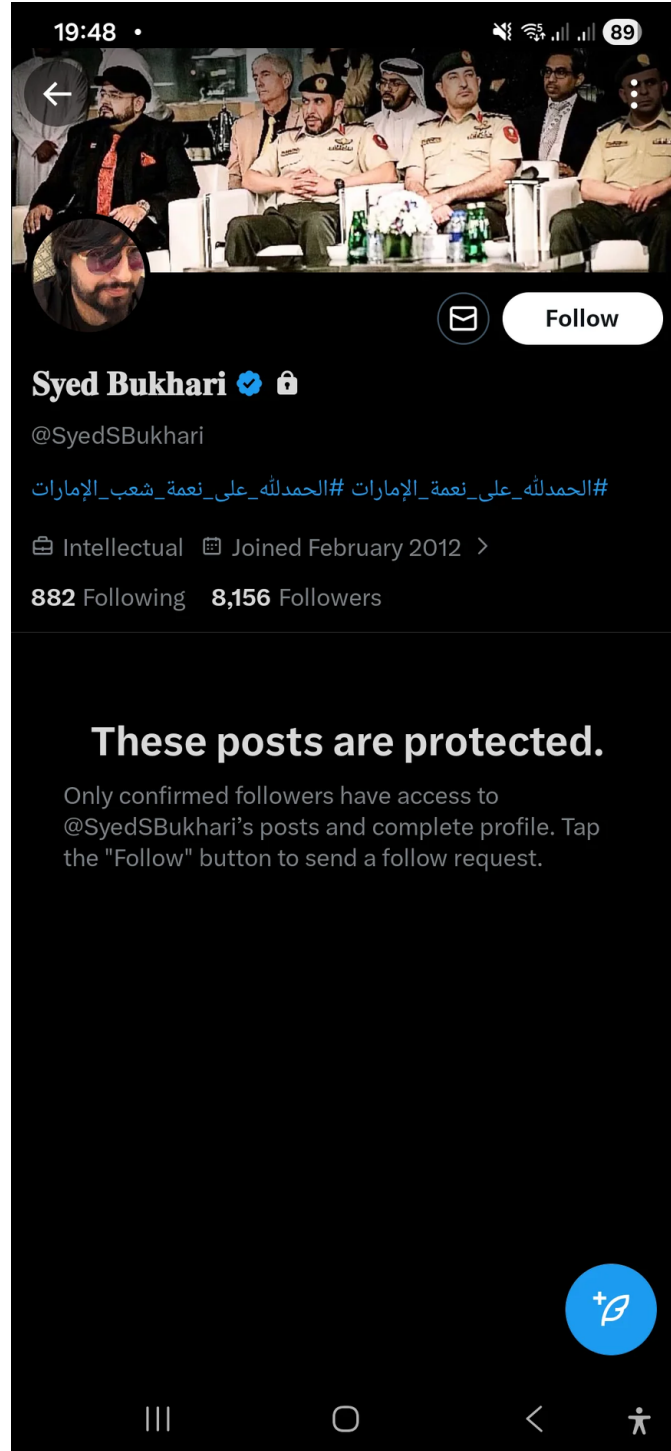

Brief. The same X account (@SyedSBukhari) that was publicly accessible at **EX-07** has since been locked (“These posts are protected”). The follower count rose from 8,146 to 8,156 between **EX-07** and **EX-21**, showing the lock happened after some activity.
