1 Disclaimer

This file is a per-person extract of the master dossier (`case_file/case.pdf`). It is not legal advice and must be reviewed by a UAE-licensed lawyer before any complaint is filed. All profane and offensive language is reproduced verbatim in translation because the exact wording is material to the seriousness of the offences being alleged under UAE law.

Note on the background / pattern exhibits. **EX-28**, **EX-29** and **EX-30** relate to a *separate* prior allegation against this person made by a different complainant (Syeda Wardah Shahid). They are included here as background / character material only. They are *not* alleged to be acts of harassment against the present Complainant.

2 Identification of this person

Name as stated in the evidence: Syeda Fizza Batool (English transliteration; Arabic display name visible on Instagram and Snapchat).

Role: Wife of the primary perpetrator (Syed Faraz Haider). When the Complainant attempted to inform her of the matter, she sided with her husband against the Complainant, told the Complainant she “deserves all that humiliation,” and opened a “negotiation” – read in context as an offer of money in exchange for take-down of the exposing posts.

Public identifiers visible in the evidence:

- **Instagram:** `@fizz_batool`, display Arabic name (transliteration “Sayyida Fizza Batool”), 166 posts, 70 followers, 661 following, account private (**EX-04**).
- **Snapchat:** `fizza_batool`, display “Fizz” (**EX-18**).
- **TikTok:** `@fizzabatool17` (**EX-29**).
- **LinkedIn:** “Fizza Batool”, “Sales Operations, Commercial Services – Informa Connect Middle East”; “Dubai, United Arab Emirates”; 109 connections (**EX-30**). The role history shows Sales Operations from April 2023 (Full-time, Hybrid) and Operations Executive from Oct 2021 – April 2023 (Contract). “Customer Service Operations and Teamwork” badge visible.

Profession and public presence

Per her LinkedIn profile (**EX-30**), Mrs. Batool is employed by **Informa Middle East** (Informa Connect Middle East) in Dubai, United Arab Emirates. Her UAE work history spans three named employers, all of them well-known Dubai-based commercial entities, and is detailed below.

Current employment: Informa Middle East. Per her LinkedIn profile and a separate B2B sales-intelligence listing for the same person, Mrs. Batool’s progression at Informa Middle East is:

- **Support Administrator** – a short-term role contributing to administrative functions.
- **Operations Executive** (Contract; October 2021 – April 2023) – responsible for process-optimisation work.
- **Sales Operations** (Full-time, Hybrid; April 2023 – Present) – her current role, focused on operational support and sales activities within the training-and-events sector.

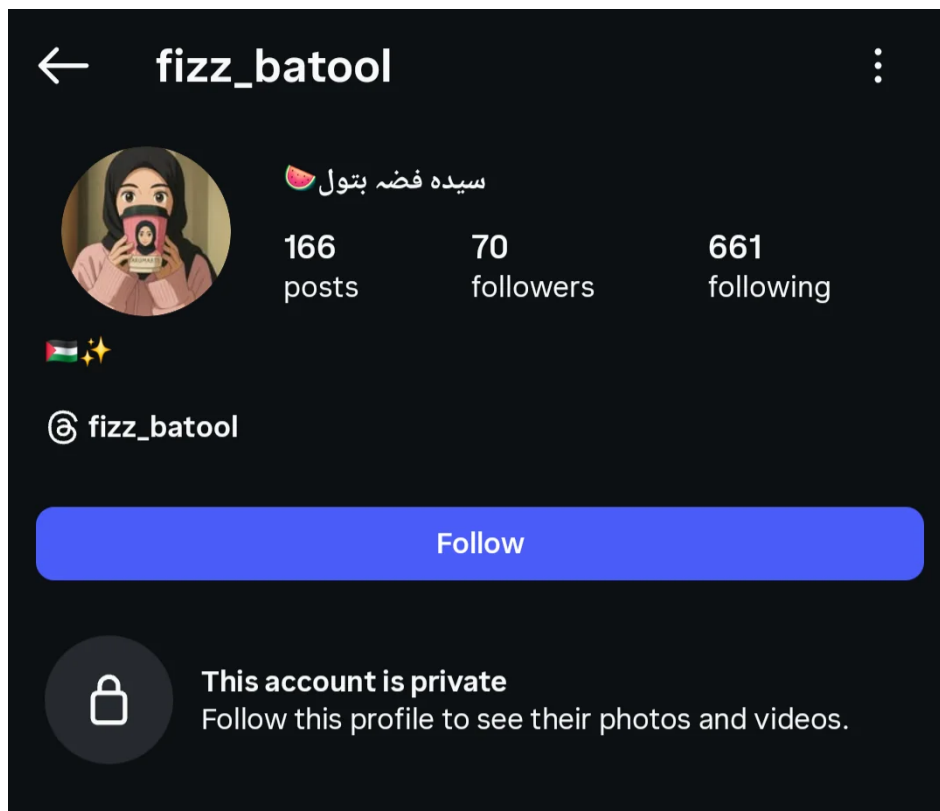
Informa Middle East is the Middle-East division of **Informa PLC** (LSE: INF), a FTSE-100 British multinational and one of the world’s largest exhibitions / events organisers; the Middle-East subsidiary runs many of the major trade shows held in Dubai and is **headquartered**

in Dubai. Her LinkedIn shows 109 connections. The published **headquarters telephone number** for Informa Middle East is +971 4 336 5161 (Dubai landline).

Earlier UAE work history.


- **DMG Events** – Telesales Executive. DMG Events is a Dubai-based exhibitions and advertising organisation; the role contributed to advertising and marketing activities.
- **Huda Beauty** (brief) – Customer Service Representative; client-support function. Huda Beauty is the Dubai-headquartered global cosmetics brand founded by Huda Kattan.

Significance for the investigation. Mrs. Batool’s social-media footprint is small in raw follower count (@fizz_batool : 70 IG followers; private) but her *employment* footprint is unusually well-documented for any of the five named individuals in this dossier: three named Dubai-based employers, a public LinkedIn profile, and an independent B2B record. Her current employer, the employer’s HR department, her Emirates ID, and her UAE residence permit are all **independently verifiable via Informa Middle East** – a formal request from UAE authorities to Informa’s Dubai HR (reachable on the published switchboard +971 4 336 5161) will return a verified identity in days, not weeks.

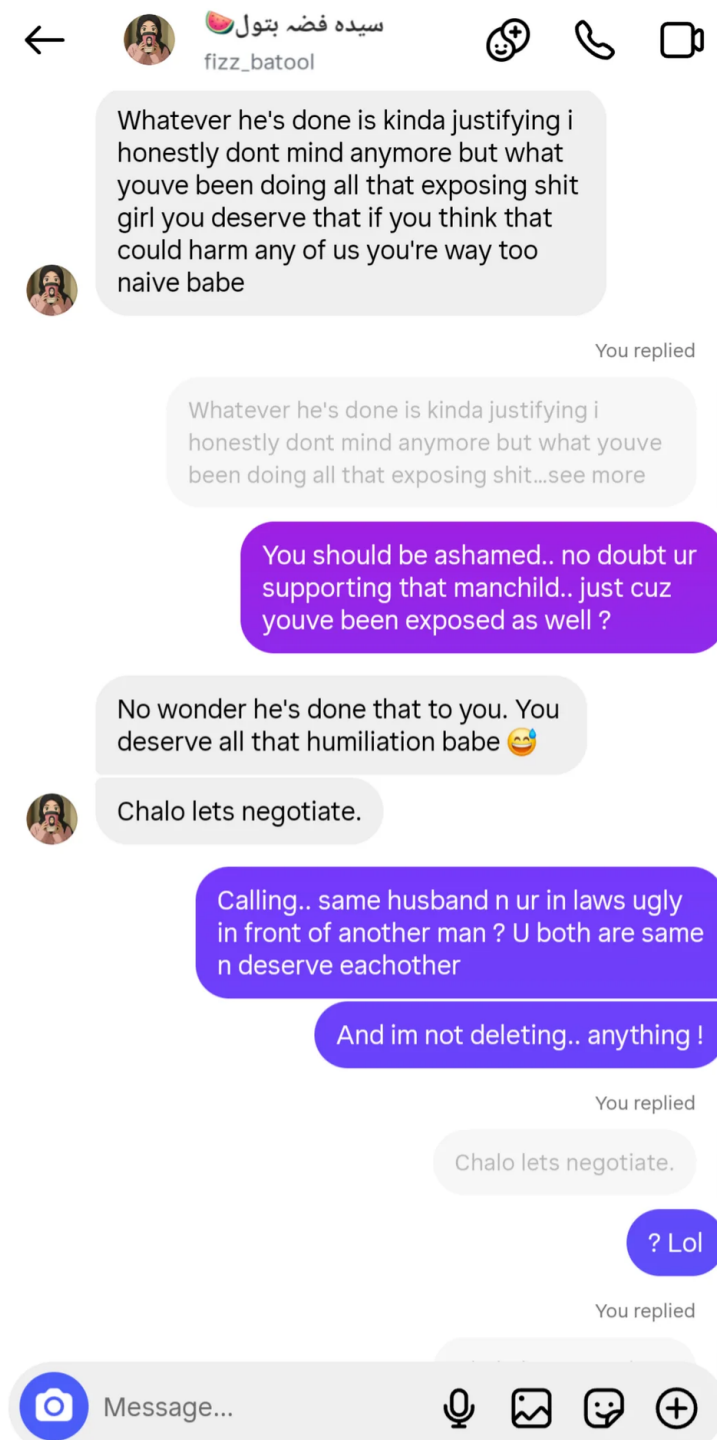
3 Acts evidenced against the Complainant

EX-11 / EX-17 — Instagram DM from @fizz_batool, source posts reddit-2 & reddit-3

Brief. The wife tells the Complainant she “deserves all that humiliation,” and opens an explicit “let’s negotiate” — read in context as an offer of money in exchange for taking the exposing posts down. (**EX-17** is the same screenshot re-posted in a later thread.)

English version (verbatim — exchange is in English):

- **“Whatever he’s done is kinda justifying I honestly don’t mind anymore, but what you’ve been doing – all that exposing shit – girl, you deserve that. If you think that could harm any of us, you’re way too naive, babe.”**
- (Complainant) “You should be ashamed. No doubt you’re supporting that manchild, just because you’ve been exposed as well?”
- **“No wonder he’s done that to you. You deserve all that humiliation babe.”**
[sweat-smile emoji]
- **“Chalo lets negotiate.”** (Roman-Urdu *chalo* = “come on”)
- (Complainant) “Calling the same husband and your in-laws ugly in front of another man? You both are the same and deserve each other.”
- (Complainant) “And I’m not deleting anything!”

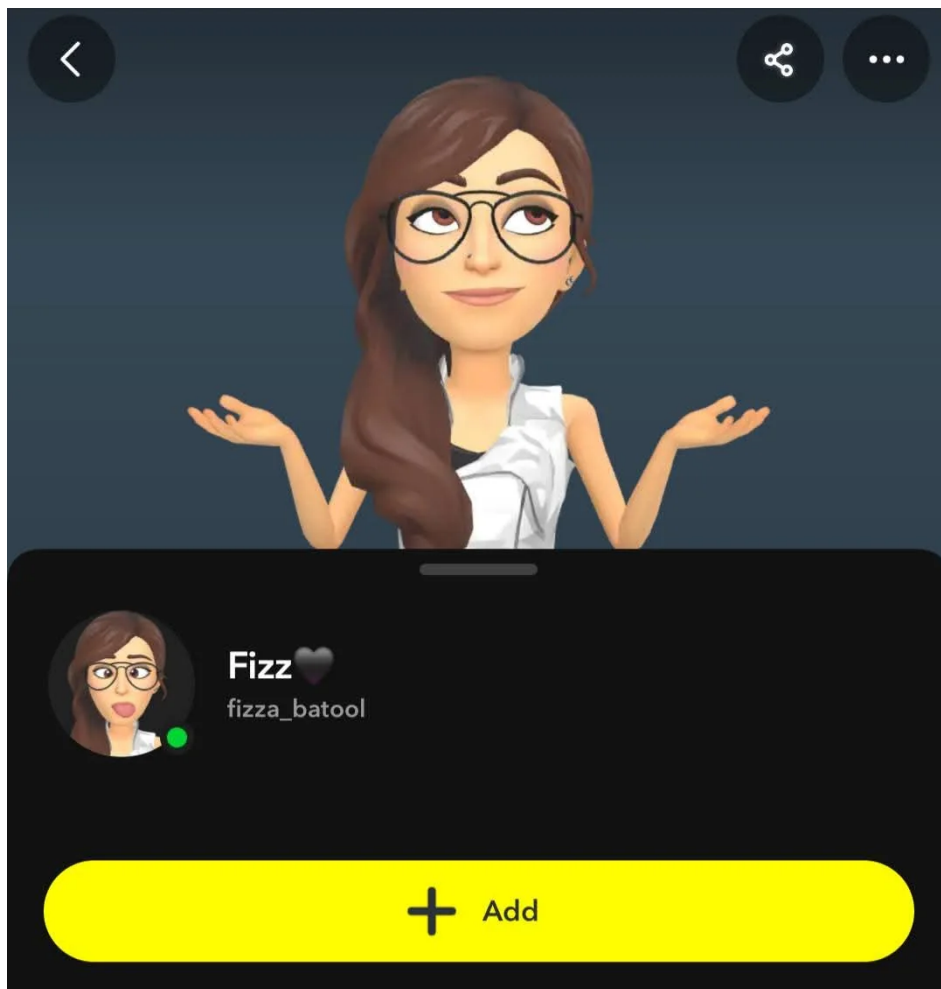

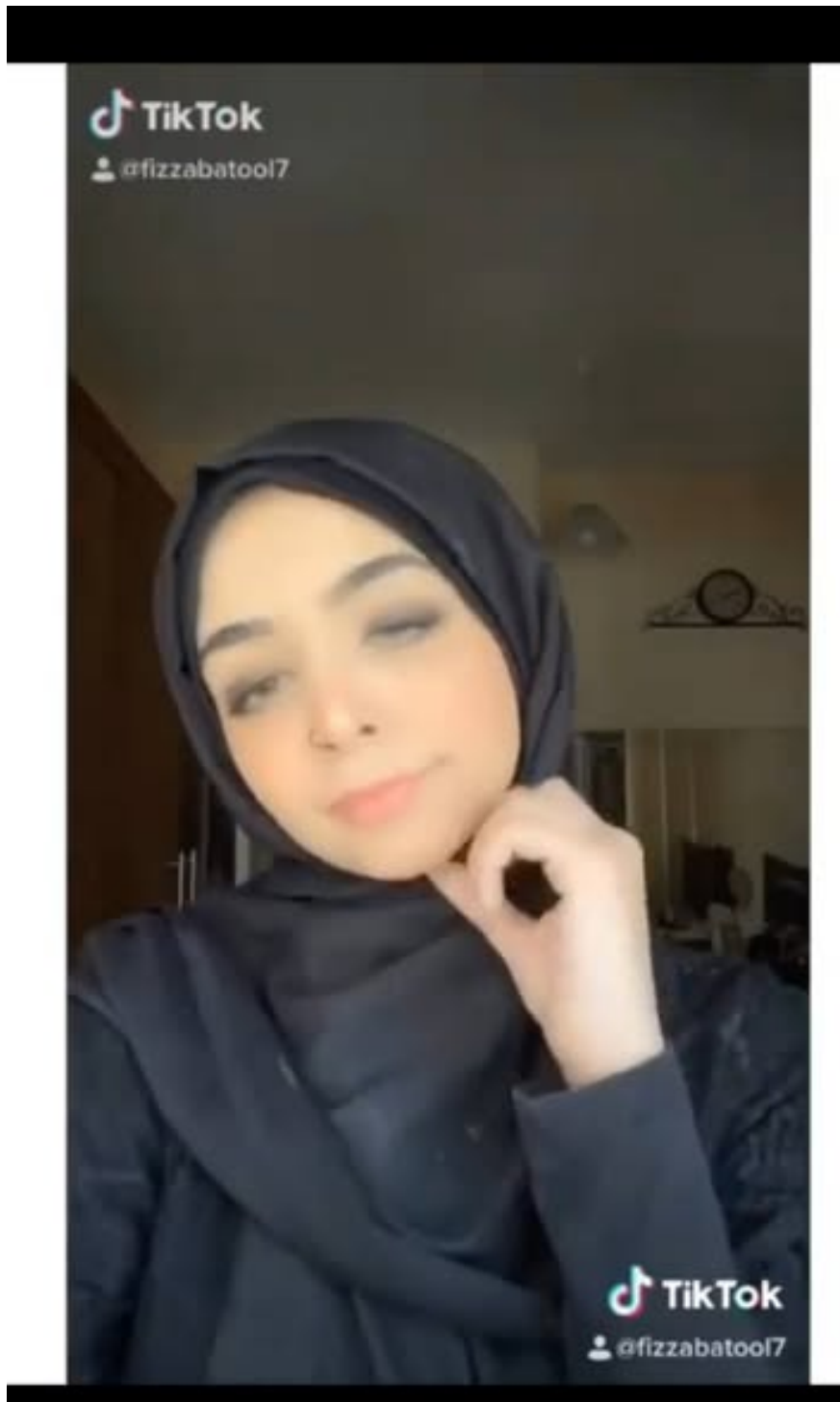

5 Background / pattern evidence (separate prior allegation)

The following exhibit is from a separate prior Facebook post by Syeda Wardah Shahid, who alleges that this person had an extra-marital relationship with her then-husband during her own pregnancies, contributing to two miscarriages. It is reproduced here only as character / pattern material; it is not an act of harassment against the present Complainant.

Verbatim text of Syeda Wardah Shahid's post (reproduced from posts/fb-another-case/post.txt):

Hello everyone... Firstly just want to say ive seen women exposing men here it needs courage but why not expose filthy women too ? I hope this gives me justice and doesnt disappoint me just because am exposing WOMAN here. For quite few days ive been seeing posts of this one guy name Syed faraz haider whos not only a harasser but his brother also harassed minors in the past. But today am not here to talk about him but about HIS WIFE. ... Syeda Fizza Batool, the woman who was seeing my "ex-husband" not only till she was single but even after when she got married. ... I have suffered two miscarriages because of Her and my ex husband. She knew he was a married man even she was married too? But she dint care nor get caught because her husband used to travel a lot. ...

6 Preliminary mapping to UAE legal provisions

Preliminary mapping, for review by a UAE-licensed lawyer.

Jurisdiction. This person self-identifies as Dubai-based on LinkedIn (**EX-30**: “*Dubai, United Arab Emirates*”; employer “Informa Connect Middle East”), and the LinkedIn role history (Apr 2023 – present and Oct 2021 – Apr 2023, both “United Arab Emirates”) confirms UAE residence over the period in which the harassment occurred.
