## 1 Disclaimer and methodology

**Disclaimer.** This dossier has been prepared as an evidentiary compilation for review by a UAE-licensed lawyer and by the relevant UAE authorities (Public Prosecution, Police, and the eCrime platform). It is *not* legal advice. Final legal characterisation of the conduct described below, and any decision to file a complaint, must be made in consultation with a UAE-licensed lawyer.

### How the evidence was collected

- Source: seven public Reddit posts authored by the victim (subreddits `r/GenZpk`, `r/LahoreSocial`, `r/PakistaniTwenties`) and one further public Facebook post by an unrelated third-party complainant against one of the same harassers. The Reddit posts and their attached screenshots were downloaded and preserved locally; the original image files are retained unchanged at `posts/` in the case folder.
- Each screenshot was visually reviewed and transcribed. Transcription was performed by direct reading of the image, not by automated OCR.
- All timestamps in this dossier are reproduced as displayed on the original screenshots (local device times). Where the source screenshot does not display a date, the field is shown as `[not in evidence]`.
- Image files are referenced by a stable Exhibit ID (`EX-01 ...EX-30`); a mapping back to the original file names is given in the *Annex* at the end of this document.

### How to read this dossier

The body of evidence is presented in two parts:

- **Part A – Evidence in English (cleaned for readability)** contains a clean English version of every exhibit – with all Urdu / Roman-Urdu / Punjabi expressions translated faithfully into English, *including the obscene language verbatim*. Profane and offensive language has *not* been sanitised: the exact wording is material to the seriousness of the offences being alleged under UAE law.
- **Part B – Original evidence (verbatim, with screenshots embedded)** reproduces each exhibit untouched: the actual screenshot is embedded in the PDF, and the original-language text is reproduced verbatim beneath it.

**Notice regarding offensive language.** *Part A reproduces obscene and offensive language verbatim in translation, and Part B reproduces it verbatim in the original Roman-Urdu, as required for evidentiary purposes. No effort has been made to censor or soften these statements; their exact wording is relevant to the conduct alleged.*

## 2 Executive summary and overview

### Who is the victim

The victim (referred to throughout as the *Complainant*) is a Pakistani national, female. In her own posts she states that she lives in Pakistan with her mother, sister and brother and that her father is deceased. She further discloses that her mother is a cancer patient. She has *not* disclosed her full legal identity in the public posts reproduced here; her personal details are to be filled in by her or by her family before the complaint is filed (placeholders are left in section 6).

### What happened, in plain English

The Complainant met a man online through a matrimonial / matchmaking application. He represented himself to her as available for marriage and, according to her account, communicated with her over a six-month period during which he repeatedly promised marriage. She later discovered that he was already married. When she confronted him, the relationship turned into a sustained campaign of online harassment, threats, image-based abuse and obscene insults — directed not only at the Complainant herself but at her family, including her cancer-patient mother (see **EX-01**, **EX-15**, **EX-16**, **EX-23**, **EX-25**, **EX-27**).

When she attempted to contact his immediate family to raise the matter, his **father**, his **brother**, his **wife**, and a **public Instagram influencer associated with the wife** each in turn joined in the harassment rather than de-escalating it. The harassing communications were sent from UAE mobile numbers (+971 56 330 6663 and +971 58 527 4179) and from verified social-media accounts on Instagram, X (Twitter), Snapchat and TikTok. Several of the senders publicly identify themselves as UAE residents.

### Scale

- Time period: approximately mid-2025 through November 2025 (Reddit post sequence 1su2xf8 through 1ufhx6u; see timeline in section 4).
- Reddit posts: **7** primary posts from the Complainant and community.
- Exhibits: **30** (29 directly evidencing harassment of the Complainant, plus **EX-28–EX-30** which constitute background material about a separate prior victim of one of the same perpetrators).
- Distinct named harassers: **5**.
- Platforms involved in the harassment of the Complainant: Reddit, WhatsApp, Instagram, X (Twitter), Snapchat. Public identity / locator material for the harassers comes additionally from Facebook, TikTok and LinkedIn.

### Categories of harm shown by the evidence

- **Obscene insults / verbal abuse** addressed to the Complainant and to female members of her family — including the words *madarchod*, *chutiya*, *randi*, *kanjri*, *haramzadi*, *bhenchod* and others (Roman-Urdu profanities). See **EX-15**, **EX-16**, **EX-23**, **EX-24**, **EX-25**.
- **Image-based abuse** – the Complainant states that her photographs were morphed and sent to her mother (referenced by her in **EX-01**: “*Morph my pictures you’ve dragged my mother already into this*”).
- **Threats**, including explicit threats of physical harm (**EX-16**: “I’ll storm into the house and get it pulled out”), a wish for an acid attack (**EX-24**: “girls like you deserve a real acid attack”), threats of being *thrown out of the UAE* (**EX-16**, **EX-22**), and threats of further public defamation by a 20,000-follower influencer (**EX-12**, **EX-20**).

- **Targeting of, and mockery of, the Complainant’s bereavement.** After the Complainant publicly disclosed that her mother was a cancer patient, the harassers continued to direct abusive messages at the mother. After the mother subsequently died, at least three of the harassers *mocked her death* explicitly (**EX-25**: from +971 56 330 6663, “*Heard her mother has died, the bitch? Sucker*”; **EX-26**: from @mairaakasim, in reply to “Her mother literally passed away”, “*Yay? She would too don’t worry :)*”; **EX-27**: from +971 58 527 4179, “*My wife is also dead like your mother*”). See the dedicated discussion of aggravating context below.
- **Attempted bribery** – the wife (@fizz\_bato01) opened a “negotiation” offering *money* in exchange for the Complainant taking down the exposing posts (**EX-11**, **EX-17**: “*Chalo lets negotiate.*”).
- **Coordinated pile-on across multiple platforms** – WhatsApp messages from two different UAE numbers, plus Instagram DMs from four different accounts, plus an X (Twitter) account that publicly amplifies the same family — spanning at least May 2025 through November 2025.

### Aggravating context – continuation and escalation after a family bereavement

*This paragraph is included only because it is directly supported by the exhibits.*

The evidence shows that the harassers were *aware*, at the time of their messages, that the Complainant’s mother was a cancer patient (the Complainant raised this herself in **EX-06**: “*my mother is suffering now because of him*”). Despite this knowledge, the harassment continued and escalated rather than stopping. After the Complainant’s mother subsequently died, three of the harassers — from two different UAE phone numbers and one verified Instagram account with ~20,000 followers — sent fresh messages that mocked or celebrated the death of the mother:

- **EX-25**: WhatsApp message from +971 56 330 6663 (the number used elsewhere in the evidence by Syed Faraz Haider) — “*Heard the bitch’s mother has died? Sucker*” (with a broken-heart emoji).
- **EX-26**: Instagram DM from @mairaakasim (verified, ~20K followers). The Complainant writes, “*Have some shame, her mother literally passed away,*” and the influencer replies “*Yay? She would too don’t worry :)*” — expressly wishing for the Complainant’s death.
- **EX-27**: WhatsApp message from +971 58 527 4179 (the number used elsewhere by the alleged father of the culprits) — “*Sleep with me, you couldn’t sleep with my son... my wife is also dead like your mother*”, combining a sexual taunt with mockery of the death.

This dossier flags this pattern — harassment knowingly continued through, and weaponised against, a bereavement and the death of a parent — because under UAE law the deliberate targeting of grief, the explicit wishing of death, and the threats of violence (including the acid-attack reference at **EX-24**) materially aggravate the seriousness of the alleged cyber-harassment and insult offences. Per the latest community post on the matter (**EX-external**, Reddit post 1ufhx6u, dated 2025), the **Complainant herself has since died**.

### What the Complainant (and her family, on her behalf) is asking

The Complainant – and now, in light of the events reported in post 1ufhx6u, her surviving family on her behalf – requests that the competent UAE authorities:

1. Register and investigate this matter as a cyber-harassment / threat / insult complaint under Federal Decree-Law No. 34 of 2021 and the relevant articles of Federal Decree-Law No. 31 of 2021 (the UAE Penal Code).
2. Identify the subscribers behind the UAE mobile numbers +971 56 330 6663 and +971 58

527 4179 via the relevant telecom operators (du / e&) and preserve their records.

3. Request from Meta, Snap Inc., X Corp. and TikTok the account and connection records associated with the handles listed in section 3.
4. Take the appropriate enforcement action against the individuals identified in this dossier who are resident in the UAE.

### 3 Identification of the alleged harassers

The named individuals below are identified in the Complainant’s own posts (see `posts/overview.txt`) and corroborated by the screenshots cited in the right-hand column. Where a handle, phone number or display name is visible on the screenshot itself, it is reproduced *exactly* as displayed.

## 4 Timeline of the alleged harassment

The table below collates every harassing act evidenced in the screenshots, in the order it appears in the source Reddit posts. Date / time fields are reproduced exactly as visible on the source screenshot; where no date is shown on the screenshot itself, only the time is given and the Reddit-post sequence is used to order the entry. Reddit post IDs are monotonically increasing in posting order, so the post-level ordering below is reliable.

## Part A — Evidence in English (cleaned for readability)

*This section reproduces obscene and offensive language verbatim in translation as required for evidentiary purposes. No sanitisation has been applied.*

Part A is organised into two subsections so the reader can move quickly through the case:

- **A.1 – Identification exhibits.** The 12 exhibits that identify the harassers (public profiles, photographs) are listed compactly here. They contain no harassment text in themselves; the actual screenshots are in Part B.
- **A.2 – Harassing communications.** The 13 distinct harassing communications evidenced, in chronological order by act (not by exhibit), with sender, English translation of the content, and a note where the same screenshot was re-posted by the Complainant in a later Reddit thread.

## A.2 — Harassing communications, in chronological act order

The thirteen distinct harassing communications evidenced in this dossier are listed below in the order they appear in the source Reddit posts. Where the same screenshot was re-posted by the Complainant in a later Reddit thread, the duplicate exhibit number is given in parentheses (e.g. “**EX-10** (also **EX-15**)”) instead of repeating the content.

### Act 1 — WhatsApp threat over the Complainant’s photographs

**Exhibit: EX-01. Sender:** +971 56 330 6663 (Syed Faraz Haider). **Source post:** reddit-1. **Time:** 03:11–03:17.

The Complainant confronts him about having lied to her. He responds by threatening her with photographs she had shared with him in private (“*You know about the pictures too – what else am I going to do, then?*”) and tells her “*Go to hell, sisterfucker*” (Roman-Urdu “*Bhaar main jaa bc*”; bc = *bhenchod*). She replies that he has dragged her cancer-patient mother into the matter and that she has loved him, and ends with “*May u die the most painful death faraz !!!!*” – this is the line that identifies the recipient of the chat as Faraz himself.

### Act 2 — Brother’s first DM: “Girls like you deserve such treatment”

**Exhibit: EX-06. Sender:** [@syedsbukharie](#) (verified Instagram, the brother). **Source post:** reddit-1.

The Complainant approaches the brother to ask him to intervene with the primary perpetrator. Instead of de-escalating, he replies: “*Girls like you deserve such treatment – Ok? Now stay away from our family or else you will see the consequences :)*”

### Act 3 — WhatsApp mockery for filing a case

**Exhibit: EX-10** (also re-posted as **EX-15**). **Sender:** +971 56 330 6663 (Syed Faraz Haider). **Source posts:** reddit-2, re-posted in reddit-3. **Time:** 01:37–01:38.

*“Why are you hell-bent on getting yourself fucked, sisterfucker?”* (Roman-Urdu *“Kyun gaand phrwane pr tuli hoi mc”*; mc = madarchod). *“You filed a case, what did you get – jack shit.”*

#### Act 4 — Wife’s “you deserve humiliation” + attempted bribery

**Exhibit: EX-11** (also re-posted as **EX-17**). **Sender:** @fizz\_batool (Instagram DM, the wife). **Source posts:** reddit-2, re-posted in reddit-3.

The wife tells the Complainant: *“You deserve all that humiliation, babe”* and *“If you think that could harm any of us, you’re way too naive, babe.”* She then opens an explicit *“Chalo lets negotiate”* – read in context, an offer of money in exchange for the Complainant taking down her exposing posts. The Complainant replies that she will not delete anything.

#### Act 5 — Influencer’s first threat: “my followers would do the rest”

**Exhibit: EX-12** (extended into **EX-20**). **Sender:** @mairaakasim (verified Instagram, ~20.8K followers). **Source post:** reddit-2.

*“What’s done is done. Stop with your ‘Complaining’ thing. Better stay away from my friend. Or else it’d not take me a sec to put up a story about you, your number or even pictures of your family and make you a proper villain and my followers would do the rest of the work then. Not warning but telling you :)”*

#### Act 6 — Father’s WhatsApp: “delete posts about my sons” + physical-violence threat

**Exhibit: EX-16**. **Sender:** +971 58 527 4179 (Shakil Bukhari). **Source post:** reddit-3. **Time:** 19:36.

*“Mother, hey – delete posts regarding my sons.”* Followed immediately by: *“I’ll storm into your house and get [you] pulled out / fucked, my sons’ whore”* (Roman-Urdu *“Ghar mai ghuss kar marwa dena hei ukharo phir mere beto ka randi”*).

#### Act 7 — Brother’s second DM: “Listen to my daddy” + threat of consequences

**Exhibit: EX-22**. **Sender:** @thesyedbukhari (verified Instagram, the brother’s second account). **Source post:** reddit-3. **Time:** 08:03.

*“Phatt gayi beta jee”* (approx. *“Got scared, kiddo?”*; the Roman-Urdu is crude). *“By leaking my socials and posting about my brothers you actually thought they’ll kick us out from uae? Awie :) Listen to my daddy now or else be ready to see the consequences.”*

#### Act 8 — Influencer’s doubling-down: “Well deserved”

**Exhibit: EX-20** (the full thread of which **EX-12** is the opening). **Sender:** @mairaakasim. **Source post:** reddit-3. **Time:** 20:03 (the day’s second message).

After the Complainant attempts to report the influencer’s account, the influencer doubles down: *“Girl you actually thought few people out there would report my account and I’ll get scared and stop posting? I feel really bad for you at this point. Well deserved (rolling-on-floor-laughing emoji).”*

#### Act 9 — Primary perpetrator’s WhatsApp escalation, after blocking

**Exhibit: EX-23**. **Sender:** +971 56 330 6663 (Syed Faraz Haider). **Source post:** reddit-4. **Time:** 22:22–22:27.

The Complainant has blocked the sender by this point (“You blocked this person. Tap to unblock” line is visible at the bottom of the screenshot). Despite this, the following messages were captured: *“Motherfucker, do you think your daughter will get you out?”* → *“You are*

*whore-children – your whole household is.*” → “Posting screenshots, showing them to two-four people, you thought you’d scare us? Right.” → “Generations will remember.” → “You’ll die yourself, you’ll drive your daughter mentally insane too, bastard woman” (Roman-Urdu “Tu tou maraygi teri beti ko bhi dimaaghi majboor kardenā haramzadi”).

### Act 10 — Brother’s third DM: explicit acid-attack threat

**Exhibit: EX-24. Sender:** @thesyedbukhari . **Source post:** reddit-4. **Time:** 10:50.

“You are whores, you and the women of your household. If I were in my brother’s place I’d do the same – whores like you deserve a real acid attack like the ones happening these days. Try and get me out of the UAE then :)” (Roman-Urdu “Randia hon tum aur tumhare ghar ki auratain. Mere bhai ki jagah main hota same karta – Tum jaisi kanjrian asli acid attack deserve kartay ho jo aaj kal horha hai. Nikaal kar dikhao shabah uae se :)”).

[Subsection break] — The following three messages were sent *after* the Complainant’s cancer-patient mother died

### Act 11 — Primary perpetrator mocks the death

**Exhibit: EX-25. Sender:** +971 56 330 6663 (Syed Faraz Haider). **Source post:** reddit-5. **Time:** 11:52.

Sent unprompted, on a fresh conversation thread: “Heard the bitch’s mother has died?” (Roman-Urdu “Maa marr gyi hei chutiya usski suna hai?”) followed by “Sucker (broken-heart emoji)” (“Chutu”).

### Act 12 — Influencer wishes the Complainant herself dead

**Exhibit: EX-26. Sender:** @mairaakasim . **Source post:** reddit-5.

The Complainant writes “Have some shame – her mother literally passed away.” The influencer replies: “Yay? She would too don’t worry :)”.

### Act 13 — Father’s WhatsApp: sexual taunt + mockery of the death

**Exhibit: EX-27. Sender:** +971 58 527 4179 (Shakil Bukhari). **Source post:** reddit-6. **Time:** 18:57–18:58.

“Sleep with me, you couldn’t sleep with my son” (Roman-Urdu “Meray sath sou jao meray betay k sath so nai saki”). Followed by: “My wife is also dead like your mother (pensive-face emoji).”

The Complainant published this exhibit on Reddit under the caption “In khabeeso ki maa betiyan nae hain ??” — English: “Don’t these foul people have mothers and daughters of their own??”

**Background / pattern:** prior allegation against @fizz\_batool

**Exhibits: EX-28–EX-30** (still frame from a video; TikTok handle confirmation; LinkedIn identification).

A separate prior allegation by a different complainant (Syeda Wardah Shahid) accuses @fizz\_batool of having had an extra-marital relationship with her then-husband during her own pregnancies. It is included *only* as character / pattern material concerning @fizz\_batool and is *not* an act of harassment against the present Complainant. The full text of Syeda Wardah Shahid’s Facebook post is reproduced verbatim in Part B (with **EX-28**).

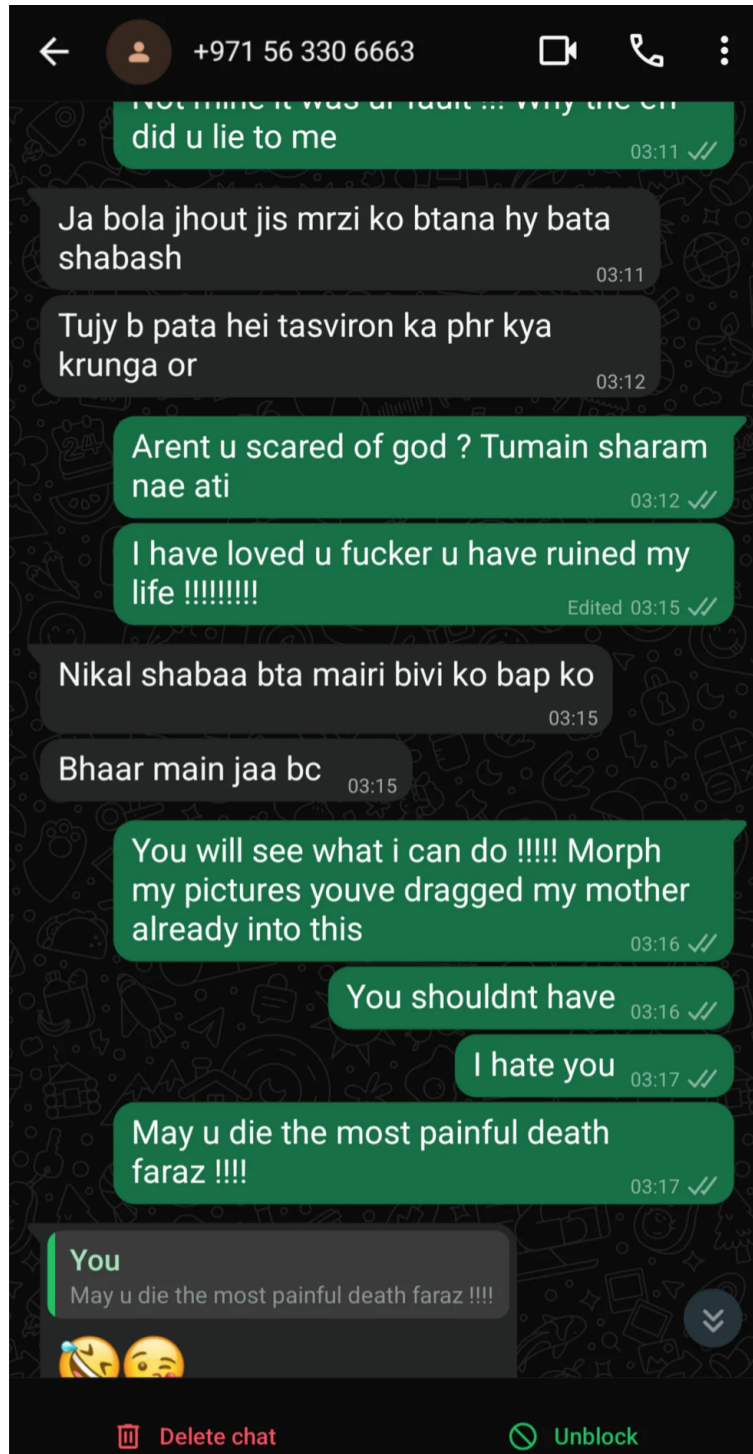

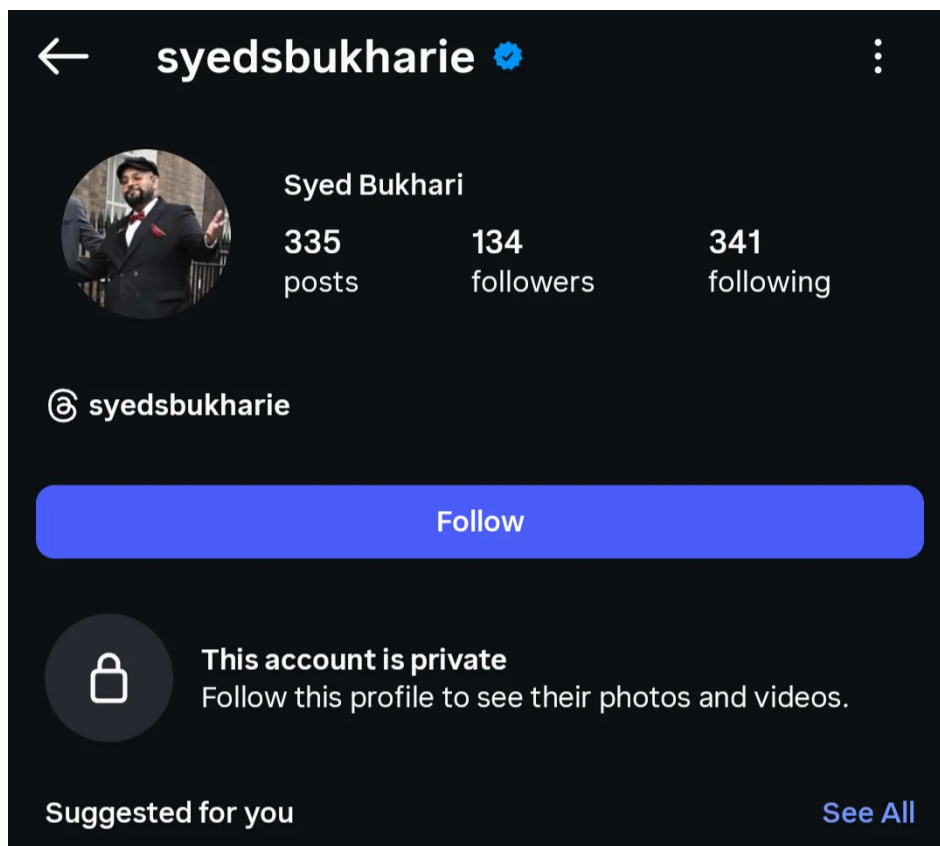

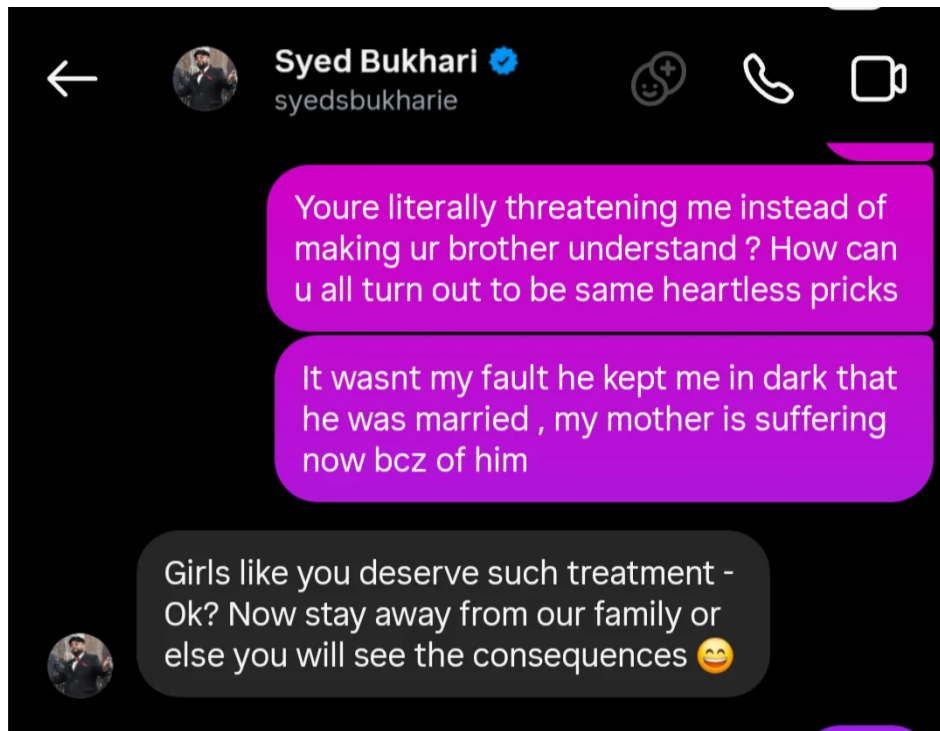


Exhibit EX-06 — Instagram DM, source post reddit-1.

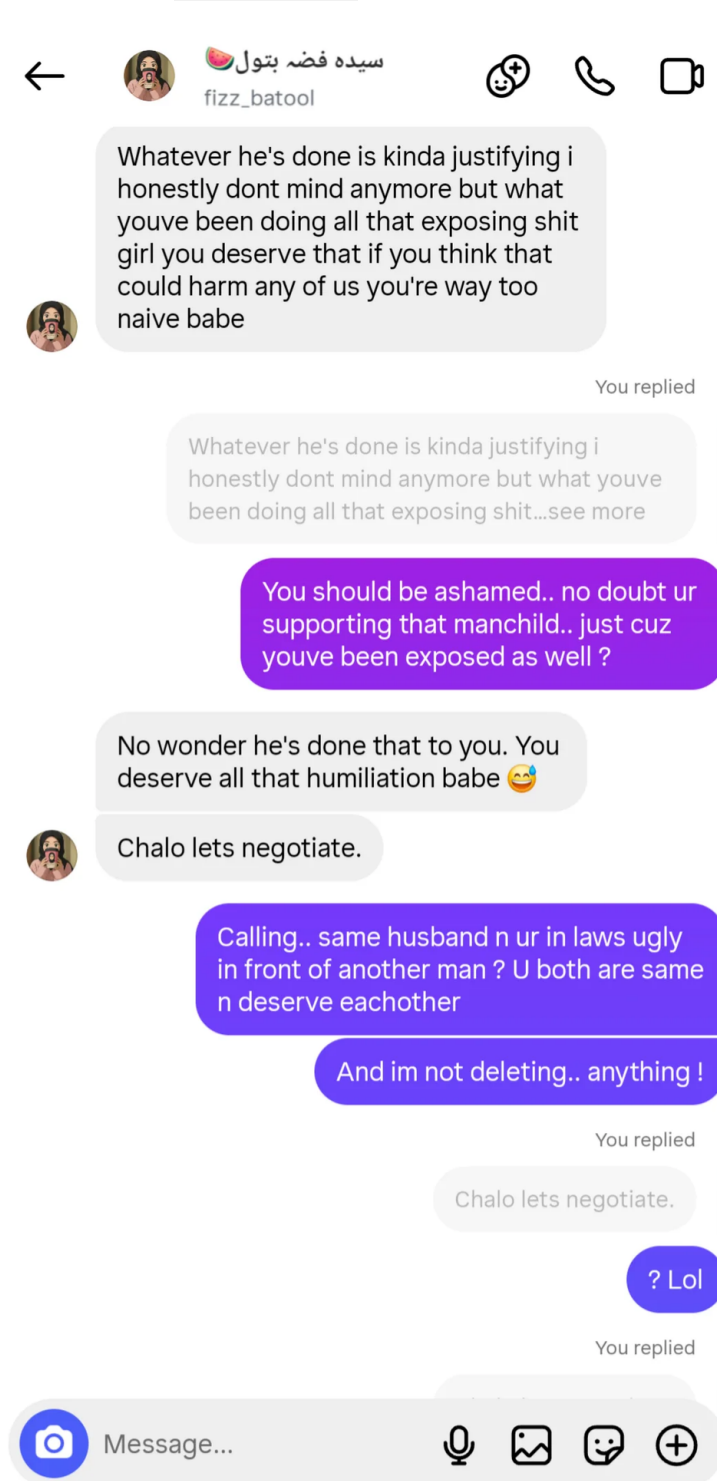

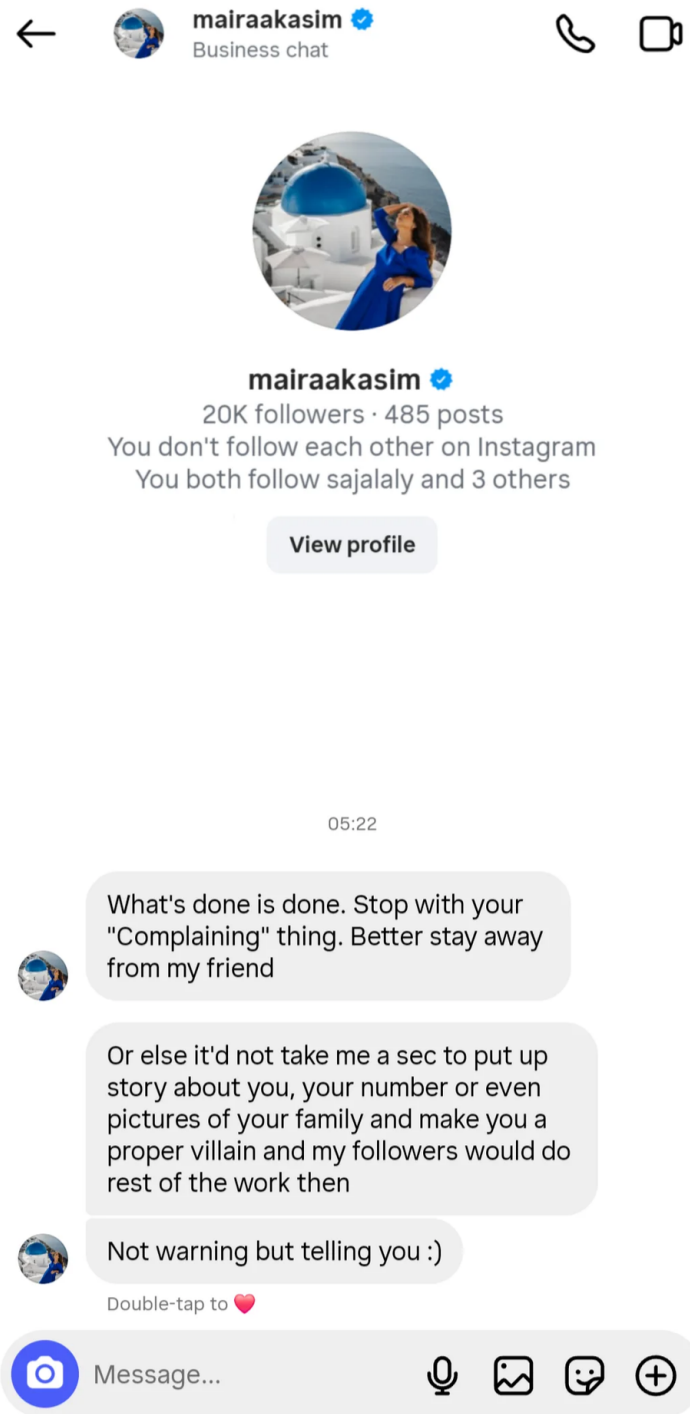


Exhibit EX-12 — Instagram DM from the influencer, source post reddit-2.

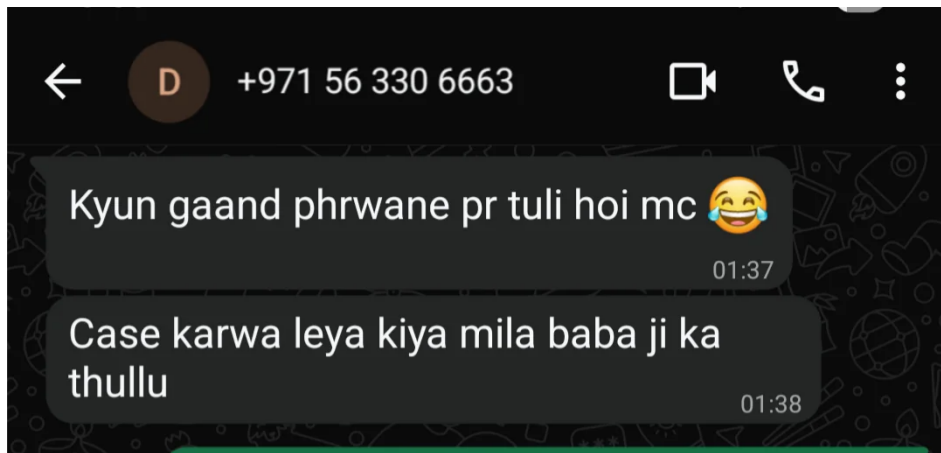

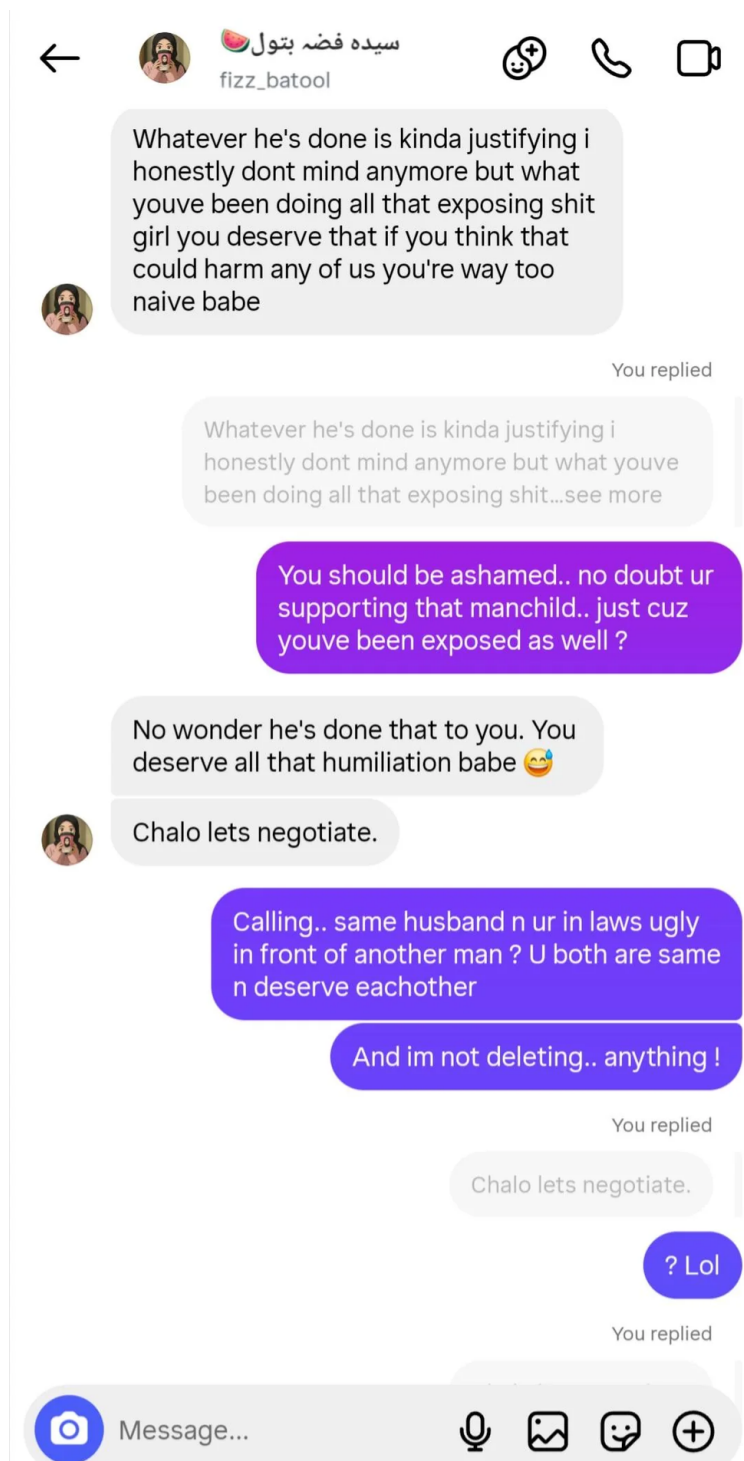


Exhibit EX-17 — Instagram DM from the wife (re-posted in reddit-3).

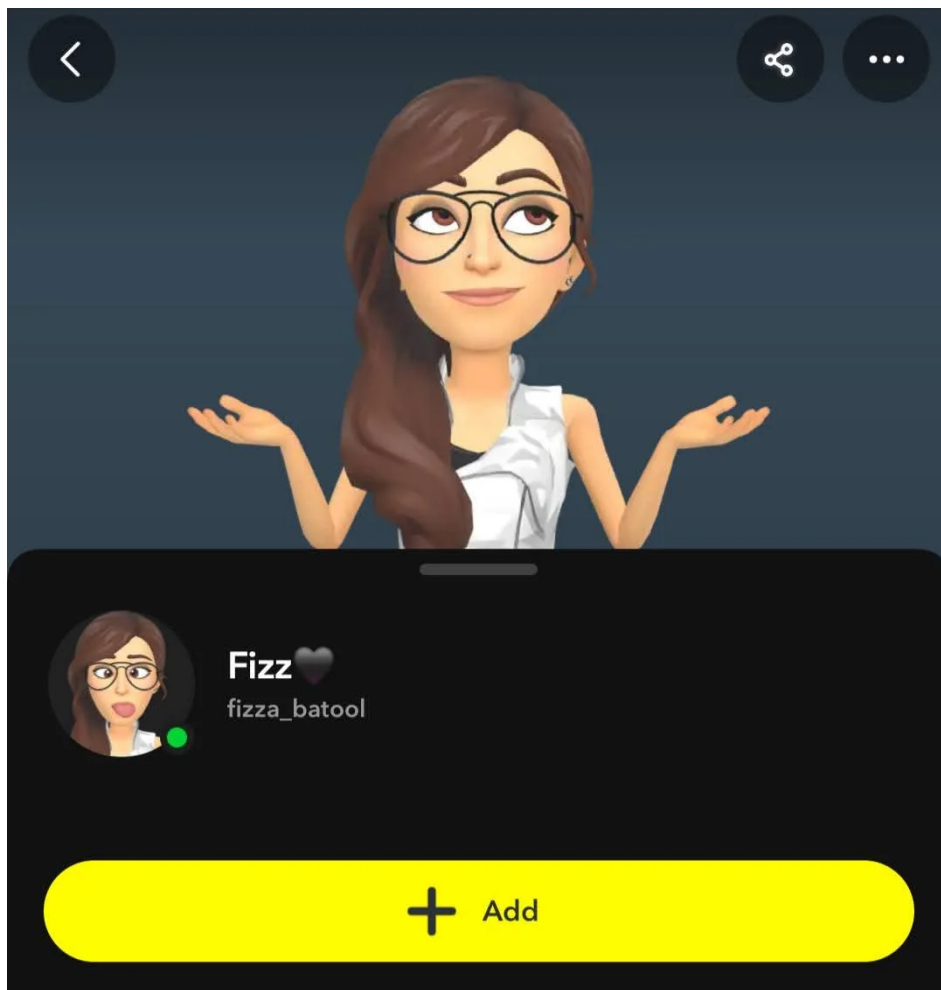


Exhibit EX-18 — Snapchat profile card.

And wo mere walay k saath gul charay uraa rai hoti thi. When i got to know all this i texted her husband but he didnt flinch he MOCKED me and my miscarriages reports which i showed to him now im realizing because hes been doing same shitty stuff with other girls too . Donon ek dusry jaisy thy. These are the conversations ive screen recorded of my ex husband and that woman. Ya lol that woman used to mock her in laws and her husband infront of my exhusband lol i have suffered hell because of these two people.. losing a child isnt a joke i hope they both d\*\* most painful dea\*\* Pls stay away from this woman if u see her again sending u any request lol i know..she has closed her dm requests no one can text her but these are the profiles of her brother and bf who mustve supported her too n thats her sc.

The two WhatsApp numbers used (+971 56 330 6663 and +971 58 527 4179) are UAE numbers. @SyedSBukhari (**EX-07**) publicly identifies as a UAE resident, the LinkedIn profile at **EX-30** identifies @fizz\_batool as Dubai-based, and the Facebook search hit at **EX-08** identifies the primary perpetrator “Syed Haider” as living in Dubai. @mairaakasim’s public Instagram bio (**EX-19**) self-identifies as “Dubai Based.”

**Disclaimer.** The above is a preliminary mapping. Final legal characterisation, the specific articles to be relied upon, and the strategy of any complaint must be settled by a UAE-licensed lawyer.

**Re:** Complaint of online harassment, threats and insult under Federal Decree-Law No. 34 of 2021 and the UAE Penal Code.

1. Between approximately [start date] and the present, I have been subjected to a sustained campaign of online harassment and abusive communications by the following individuals, all of whom are connected to one another by family or friendship and several of whom are resident in the United Arab Emirates:
  - Mr. Syed Faraz Haider (Instagram @faraxhaider ; WhatsApp +971 56 330 6663; resident, per public Facebook profile, of Dubai, UAE).
  - Mr. Shakil Bukhari (Facebook “Shakil Bukhari”; WhatsApp +971 58 527 4179; identified as the father of Mr. Faraz Haider).
  - Mr. Syed (Sheraz) Bukhari (X / Twitter @SyedSBukhari ; Instagram @syedsbukharie , also @thesyedbukhari ; identified as the brother of Mr. Faraz Haider; self-identifies publicly as a UAE resident).
  - Mrs. Syeda Fizza Batool (Instagram @fizz\_batool ; Snapchat fizza\_batool ; TikTok @fizzabatool7 ; LinkedIn “Fizza Batool, Informa Connect Middle East, Dubai, UAE”; identified as the wife of Mr. Faraz Haider).
  - Ms. Maira (Asad) Kasim (Instagram @mairaakasim , verified, ~20,000 followers; self-identifies as Dubai-based).
2. Annexed to this complaint are 30 exhibits (numbered **EX-01** through **EX-30**) which document the said communications. The exhibits include WhatsApp message screenshots from the two UAE numbers identified above, direct-message screenshots from each of the Instagram and Snapchat accounts identified above, and public-profile screenshots that identify the individuals named above.
3. The communications include, without limitation: (a) obscene and degrading insults addressed to me and to female members of my family; (b) explicit threats of physical harm, including a written reference to my deserving “*a real acid attack*”; (c) threats by an Instagram account with ~20,000 followers to publish my telephone number, my family photographs, and a defamatory story about me; (d) an attempted bribe to procure deletion of my exposing posts (“*Chalo let’s negotiate*”); and (e) mockery, after my mother’s death, of that bereavement, from three separate sources — two WhatsApp numbers and one verified Instagram account.
4. I have previously attempted to engage the relevant family members to procure cessation of this conduct; they instead joined in. I had also previously reported the matter through [FIR reference] / via the eCrime portal under reference [reference number, if any]; the conduct has continued and escalated.

5. I respectfully request that the competent authority:

- (a) register this matter as a complaint of online harassment, threats and insult under Federal Decree-Law 34/2021 and the relevant articles of the Penal Code;
- (b) issue the necessary requests to the UAE telecom operators to identify the subscribers behind +971 56 330 6663 and +971 58 527 4179;
- (c) issue the necessary requests to Meta Platforms, Inc., Snap Inc., X Corp. and TikTok for the account / connection records associated with the handles listed above;
- (d) take the appropriate enforcement action against the individuals named above who are resident in the UAE.

**Declaration.** I declare that the facts set out above are true to the best of my knowledge and belief, and that the exhibits annexed to this complaint are true copies of communications I received or, in the case of public-profile exhibits, are true captures of publicly displayed information.
